AI Expansion to Stay on Course: Lohani

The carrier launched a flight to Washington, which is its fifth American destination

Virginia: Air India's expansion will continue unhindered even as talks and proceedings of its privatisation are on, the national carrier's chairman has said.

On board the carrier's launch flight to Washington on Thursday, Ashwani Lohani told ET that privatisation is the government's job, while the management's job is to look at expansion.

Washington is Air India's fifth American destination,

apart from New York, Newark, Chicago and San Francisco. The airline plans to add Los Angeles in October.

Air India will also add Stockholm on August 15 and Copenhagen thereafter, as it gets the 24th, 25th and 26th of its 27 ordered Boeing 787 Dreamliner planes.

This happens even as privatisation plan for the airline gathers steam.

However, two senior executives said separately that the airline has put its plan of leasing seven additional Dreamliners on hold, given the talks of privatisation.

Meanwhile, Rakesh Gangwal and Rahul Bhatia, co-owners of budget carrier IndiGo Airlines which has expressed interest in buying a stake in the airline, have clarified that their primary interest in Air India is in their international operations which include the low-cost Air India Express.

They also stated that they are not keen to partner the state in a joint venture for the flagship airline.
